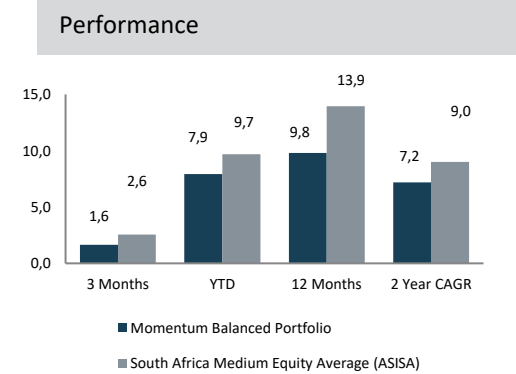
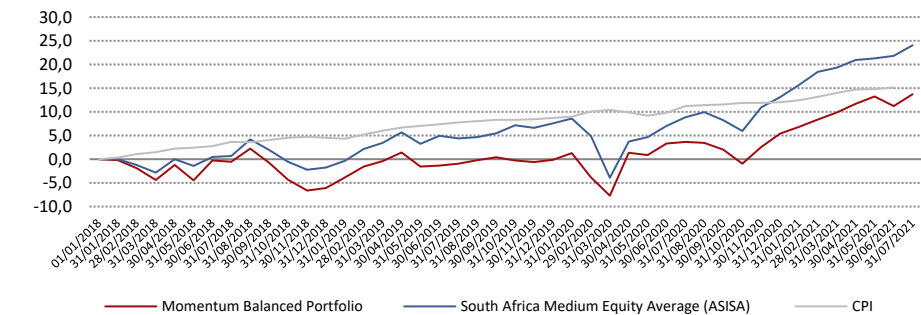


Balanced Portfolio

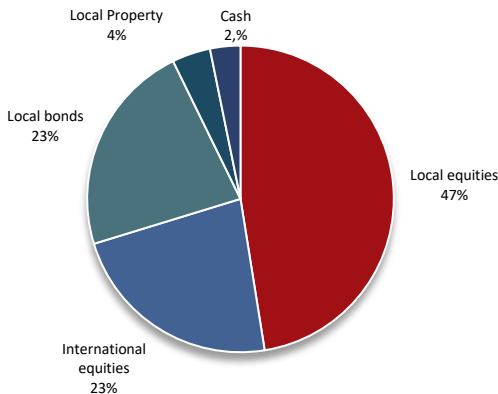
