

Balanced Portfolio

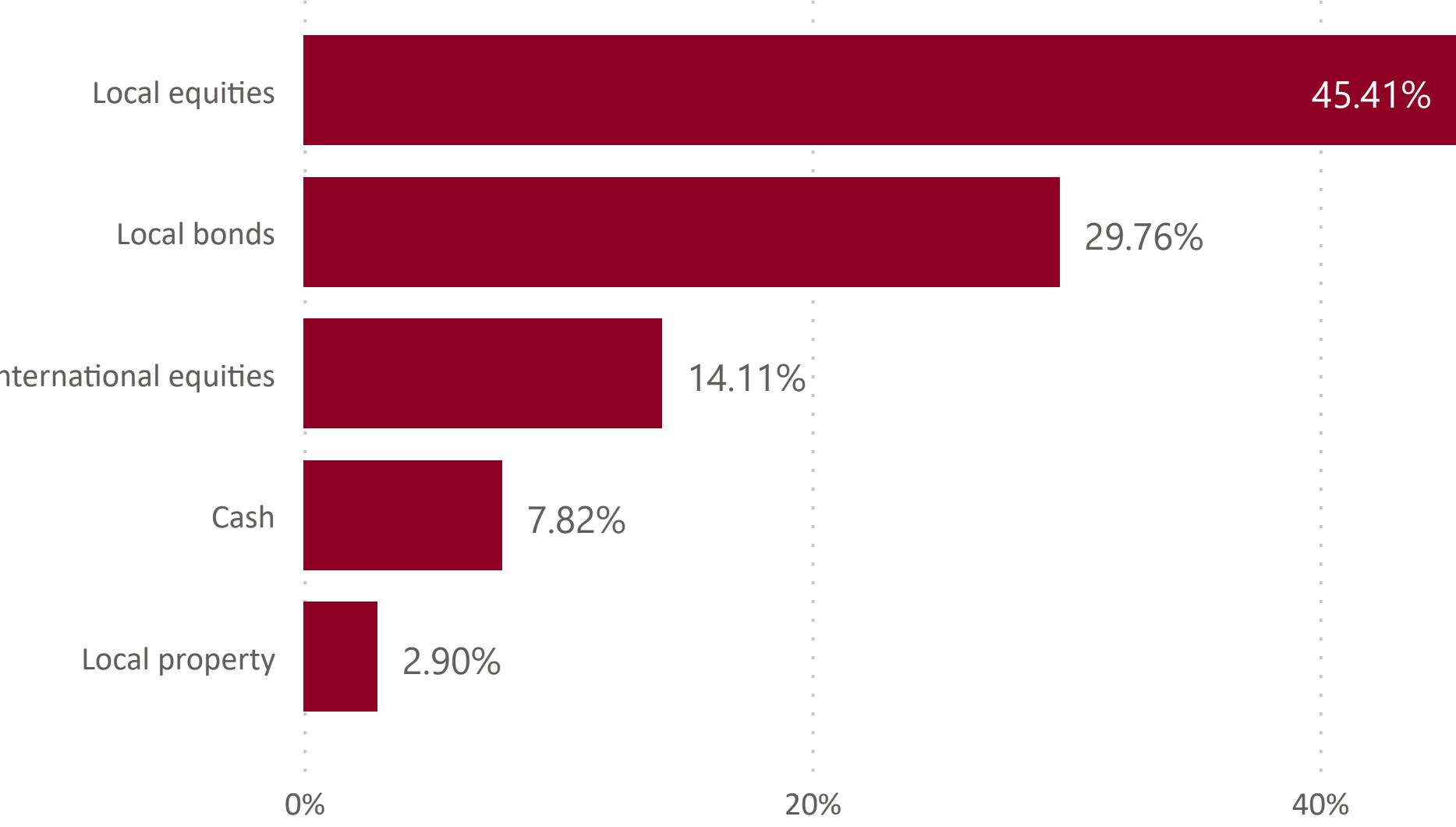
Investment Objective
